

WILL of REBECCA ALLEN of GRANGE, CO SLIGO

In the name of God amen. I Rebecca Allen of Grange in the County of Sligo being sound in mind and in perfect memory and understanding do hereby make my last will and testament revoking all others hitherto made by me.

First I bequeath to my niece Sarah Allen the sum of two hundred pounds (L200) with the furniture of my house in Grange and all indoor effects.

Secondly I bequeath to my nephew William Kinlands the sum of two hundred pounds (L200).

Thirdly I bequeath to my niece Mrs Rebecca Inman the sum of fifty pounds (L50)

Fourthly I bequeath to my niece Mrs Margaret Beglar the sum of fifty pounds (L50)

Fifthly I bequeath to my grand nephew the sum of five shillings (5s)

Sixthly I bequeath to my nephew John Allen the sum of one hundred pounds (L100)

Seventhly I bequeath to William John Moore of Grange the sum of fifty pounds (L50)

Eighthly I bequeath to my grand nephew Thomas Connor the sum of fifty pounds (L50)

Ninthly I direct my executors to pay my funeral and my testamentary expenses and to expend a sufficient amount not exceeding twenty-five pounds to provide a family tomb at Ahamlish Churchyard, the designs and inscriptions to be approved by my nephew John Allen.

Tenthly I bequeath to the Trustees for the time being of the County Sligo Protestant Orphan Society the sum of thirty pounds (L30) for the benefit of the said Society.

Eleventh I bequeath to the Representative Body of the Church of Ireland the sum of thirty pounds (L30) to be held in trust for the use of the Dioceses of Elphin Clergy Superannuation Fund.

Twelfth I direct my executors to sell by public auction or by private treaty my interests in the houses and land held by me in Grange together with cattle and all outdoor effects and to convert into money all my property real and personal and the proceeds with all other monies remaining to my credit in banks or elsewhere to be divided in proportional shares amongst the parties named in this will, my Executors together with my present landlord Jas Johnston Esq of Kinlough are to have the choice in the purchaser of my houses and lands in Grange as it is my distinct wish that a member of the Church of Ireland should have the preference and succeed me as tenant of said houses and lands.

I appoint Charles Rogers Esq of Moorfield Co Sligo and John W Tate Esq of Cliffoney, Trustees and Executors of this my Will. Witness my hand this __ day of ____.

Dated this sixth day of January eighteen hundred and ninety three.

Codicil: I Rebecca Allen do hereby make this Codicil to my last Will and Testament dated the 6th day of January 1893 . I appoint William Allen Kinlands to act as one of my Executors instead of Dr Tate.
